

Experience the World of Stone Brewing Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Experience the World of Stone Brewing Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least twenty-one (21) years old at the time of entry. Employees of Stone Brewing Co., LLC, HelloWorld, Inc., and their parent and affiliate companies as well as the immediate family (including spouses, parents, siblings, children, son-in-laws, daughter-in-laws, and lineal descendants, including those by adoption) and household members of each such employee are not eligible. Your Tweet/post and its included content will hereafter be referred to as your Submission. Your Submission must be your original work.

Submission Guidelines and Restrictions:

You automatically will receive one (1) entry into the Sweepstakes for your qualified Submission. Released Parties (as defined in Section 8, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, un-intelligible, garbled, delayed or misdirected Submissions or failure to receive Submissions due to limitation of third-party social network platforms all of which will be void.

Limit: You may enter one (1) time per day per Social Account during the Promotion Period. Each Submission must be unique to qualify as an entry. The potential winner will be notified by @stonebrewing (Instagram) or @StoneBrewing (Twitter) via Direct Message or reply message on the Social Account used to enter and will be required to provide his/her name, email address and date of birth to confirm eligibility and for prize fulfillment purposes within seven (7) days of the date notice or attempted notice is sent into order to claim

the prize. The potential winner will be required to sign and return a Declaration of Compliance, Liability Waiver and, where not prohibited, a Publicity Release ("Declaration") and his/her valid driver's license, which all must be received by Prize Administrator, within seven (7) days of the date notice or attempted notice is sent, in order to claim the prize. Travel is tentatively scheduled to occur in September 2020.** Trip must be booked at least twenty-one (21) days prior to departure. Travel and accommodations are subject to availability and blackout dates. Sponsor will determine airline and flight itinerary in its sole discretion.
